The agenda will include a review of association financials, election of a trustee to replace Mike Hawley, sharing of George South Park Project financial information, representatives from the Water Line Project and Licking County Engineers will be present to answer related questions. All HH residents are invited and encouraged to attend.

Information about the proposed George South dock project will be emailed to all residents as well available at the annual meeting. The trustees have chosen to wait to hold a vote on how to proceed in October rather than at the annual meeting. We feel it is important that residents can review the rendering of the area and have financial information relevant to the project.

- In preparation for the Annual HHCA meeting, a brochure of information regarding the George South project will be emailed to all residents. These will also be available at the annual meeting. It was decided to hold a vote in October to determine how we want to proceed as a neighborhood.
- We plan to meet with Matt Hatfield, a financial advisor, prior to the annual meeting to be sure we are operating within HOA policy.
- Building requests were reviewed.

## FRIENDLY REMINDERS:

- Yard waste dumpsters will be placed at the two parks mid-October. Each dumpster will get emptied once, then be removed once they are full for the second time. It is important to dump **only yard debris** in these dumpsters. Please do not place tree limbs, plastic bags, trash, or construction material in the dumpsters.
- In regard to the letter emailed to everyone by Ian Nickey, if you have an underground dog fence or irrigation system, be sure to mark its location to avoid the possibility of damage by the waterline project folks.
- Be mindful of your neighbors' property and our parks, by continuing to pick up after your pets so we can all enjoy all neighborhood areas. Waste bins are at each of the parks for your convenience.
- If you use a golf cart to travel between Harbor Hills and Avondale, a waiver and permit are now required. Contact [NatalieHHCC@gmail.com](mailto:NatalieHHCC@gmail.com) with any questions. Cost of permit is \$25 and is good through the end of 2025.
